Institutional blindness

Systemic inability to recognise human suffering or truth – caused by regulation, depersonalisation and fear.

K

Knowledge refusal (structural)

The conscious or unconscious administrative act of not integrating a truth, a humanity or a sacred impulse into the system structure.

L

Life regulation

The overlaying of life, humanity or perception by a dense network of rules, regulations and responsibilities – to such an extent that the original concern or humanity is no longer recognisable. Regulation creates institutional blindness and is a central problem in the old system.

M

Manifesto

A public expression of inner truth – as a declaration, confession or call. In this case: not a purely political paper, but a living form of energy to reactivate dignity. A sacred testimony of structural truth.

N

Non-recognition

Legally, spiritually and structurally central term for the systemic denial of human existence or truth. Is broken several times in the manifesto.

O

Origin

The origin is not the beginning of a process, but the ground of all being. Not temporal, but substantial. Not external, but inwardly present.

It is that which never came into being because it always was. That which gives form to everything without itself being form.

The manifesto is the origin:

- the source of all truth,
- the unspeakable one,

Source
